HEAD KNOWLES GINA WHERE IS THE MONEY?

Both Head Knowles founders are planning to now sue each other, mainly because of a falling out when Knowles decided not to give information on what she would be using the money collected by Go Fund Me (GFMe) to her partner HEAD, in order to file proper documentation needed for IRS and GFMe, Lia Head understood how important these filling are and how it should be taken serious and not be false reported, so she sent emails to Gina asking her to truthfully say where the money will be going, mainly because Lia was in fear that if any mess is done it can possibly cause them both to face the courts, along with prison time. After Lia understood that proper documentation of how Gina was spending this money wasnt coming her way anytime soon, she decided to leave the company! Before stuff get really messy, but its already messy now because they both have a lot of answering to do, while proof hits the internet on large sums of money hitting Gina Knowles, entity business account here in The Bahamas.

Here's how it all played out day by day.

Sept 7th - Lia suggests hiring a full-time Disaster Relief Coordinator to run Operations in Nassau as this recovery is bigger than HK and the Govt; we need expertise on the ground and set up the foundation office for staff and volunteers; we know that volunteers start falling away by 2nd week so it's needed

Sept 7th - Lia/Gina spoke on phone to go over all IRS ramifications, the delay on the release of funds until compliant; updated her on BOA's stance and what is needed to move monies once received

Sept 9th 10AM - GFMe funds initial deposit available at BOA in Orlando - \$USD737,070.63

Sept 9th 11AM - Lia confirms funds are transferred to HK's RBC BSD account (attached) and requests a formal receipt from Gina to submit to legal team

Sept 9th - Lia being advised by her legal team regarding the IRS request, that an outline of how the \$737,000+k will be utilized as technically it will have



to be "gifted" from her personal account in the interest of time for the disaster relief victims of Hurricane Dorian. Simultaneously the paperwork for a US business account is being completed to separate funds.

Sept 9th, 2019 - Items needed to comply with the IRS and receive more funds from GFMe by opening a US Business Account:

EIN (Employer Identification Number) - (attached) (Sept 10th, 2019)

Certificate of Status - (attached)

Sept 11th - Lia reminds Gina to send the receipt; advised her again of legal outline; requested name of Accounting firm that she decided to work with on her side

Sept 12th, 2019 - Gina partially confirms receipt of funds that were deposited on 9th from Lia via picture of an RBC terminal screen; partial as a valid receipt was requested; not a shot of a computer screen

Sept 12th, 2019 - Gina agrees to close the local business account as the new local HK Foundation account is opened, so that monies can be from foundation to foundation accounts and satisfy both the Central Bank and US Banking Laws; asked for proof of closure; repeated the IRS compliance needs; Lia reiterates the separate offices and tasks, as well as establishing the US Office

Sept 13th, 2019 - The EIN/Tax compliance number and BOA business account ensures legal separation of funds from Lia/Chad's personal account, compliant with the IRS

Sept 13th, 2019 - Lia meets with attorney to finalize IRS agreements of phases

Sept 13th, 2019 - The IRS will ensure they cover Lia/Chad retroactively, since it was the only one allowed from their personal account - per GFMe and IRS requirements via the signed affidavit

Sept 13th, 2019 - Lia sent a lengthy message to HK Admin WhatsApp group to communicate the US banking legalities and ramifications, as it seemed many did not know the monies had been sent four days before on the 9th and were told there was no funds in the account; and to clarify the IRS requirements to release she and Chad from liability

Sept 16th, 2019 - First thing in the morning Lia confirms funds are transferred to the new HK Foundation's RBC BSD account (attached) - \$USD270,015.53

Sept 16th, 2019 - Throughout the day Lia receives numerous calls and messages from friends, family and the press hearing that HK had split, asking if she knew. She did not.

Sept 16th, 2019 - By day's end Lia decided to break ties and safeguard the brand, to continue

Sept 16th - 22nd - Submitted the request to close GFMe and have been working diligently

to satisfy their requests of reporting and accounting of the funds

Sept 17th - NPCC issue arises and Lia is made aware of a \$50K pledge made by Gina; worked to understand - NPCC states Gina/Krystinia said there was no money to pay it [\$733K is in RBC]; spoke to Elders for understanding and damage control and see how to help from the US

Sept 22nd - Lia is notified that because of there not having a Certificate of Occupancy for Phil's - ALL ACCESS to donations stored there have been on hold for the past four days - including NPCC's donations that had been moved for storage there.

FYI :: GoFundMe accounts can only be used to operate by an American registered national. [Lia] A Bahamian without a social security account cannot open an account. [Gina]

Now just two years later he is once again trying to make a come back into the spotlight for the Bahamian people, to take up his old duties as an Activist.

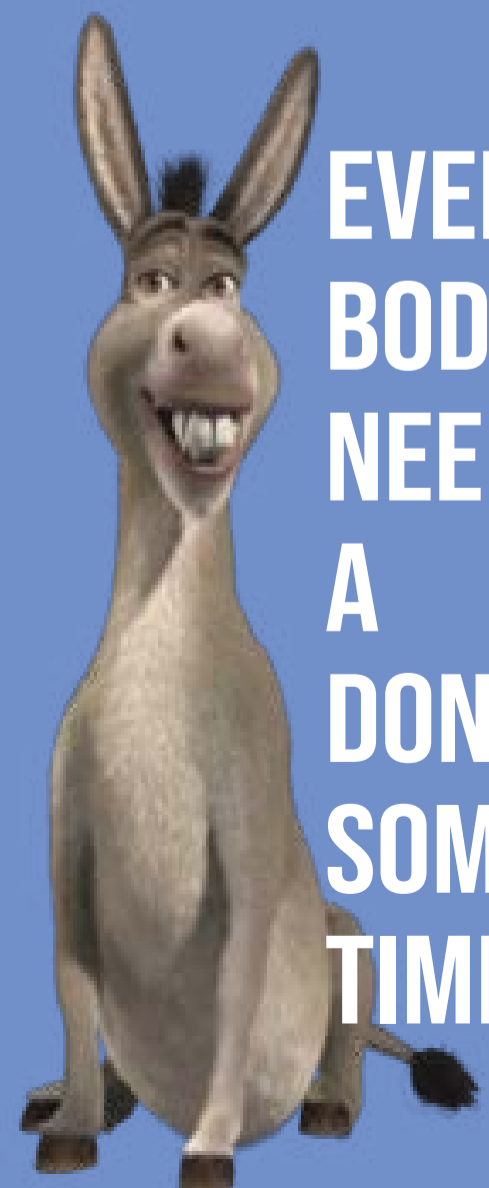
Well Omar while it's sad to say you are

SMOKE IN GRAND BAHAMA AFFECTS FLORIDA

South Florida, waking up to the smell of smoke. You may be smelling a fire in the northern Bahamas, according to the National Weather Service. Weekend satellite images showed smoke moving along Grand Bahama Island, one of the area's badly hit by Hurricane Dorian, according to Forecaster Brandon Orr. At least two large fires were detected on the island Saturday afternoon, according to WPLG. But, while the cause of the fires are unclear, Brandon Orr said the weather service hasn't heard any reports of a wildfire. He says it's

likely debris is being burned on the island and that the winds are carrying it to South Florida's coast during the early morning. The satellite image was too dark early Monday morning to tell if the fires were still burning, Orr said, but he expects to have a better image once the sun rises more. If the fires are still burning, your air won't have a smokey tinge to it all day, said Brandon Orr, Local 10's meteorologist. "In the morning that smoke comes pretty close to the ocean, pretty close to the ground," said Orr during a weekend forecast. "That's why we're smelling it in the morning — and once we

heat up — that smoke lifts above us and that's why we're not smelling it anymore." Depending on the wind, both forecasters say those along the coast may continue to wake up to the smokey scent until the fires are extinguished.

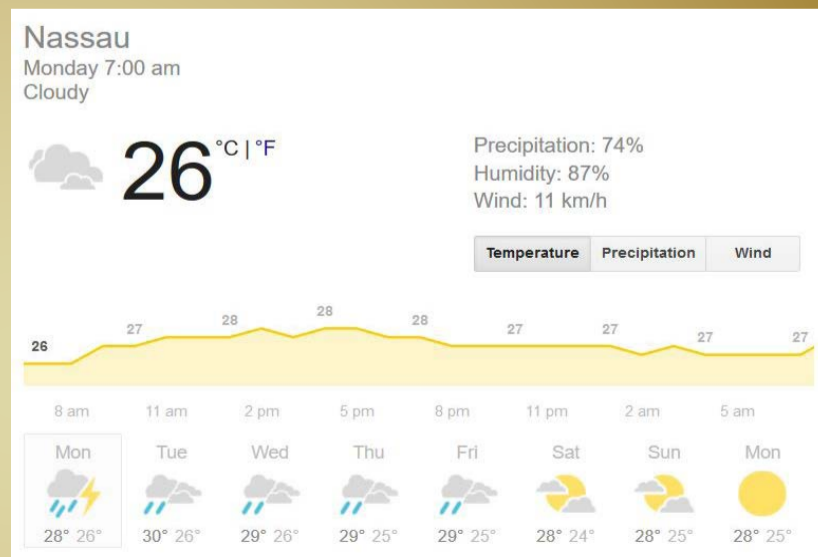

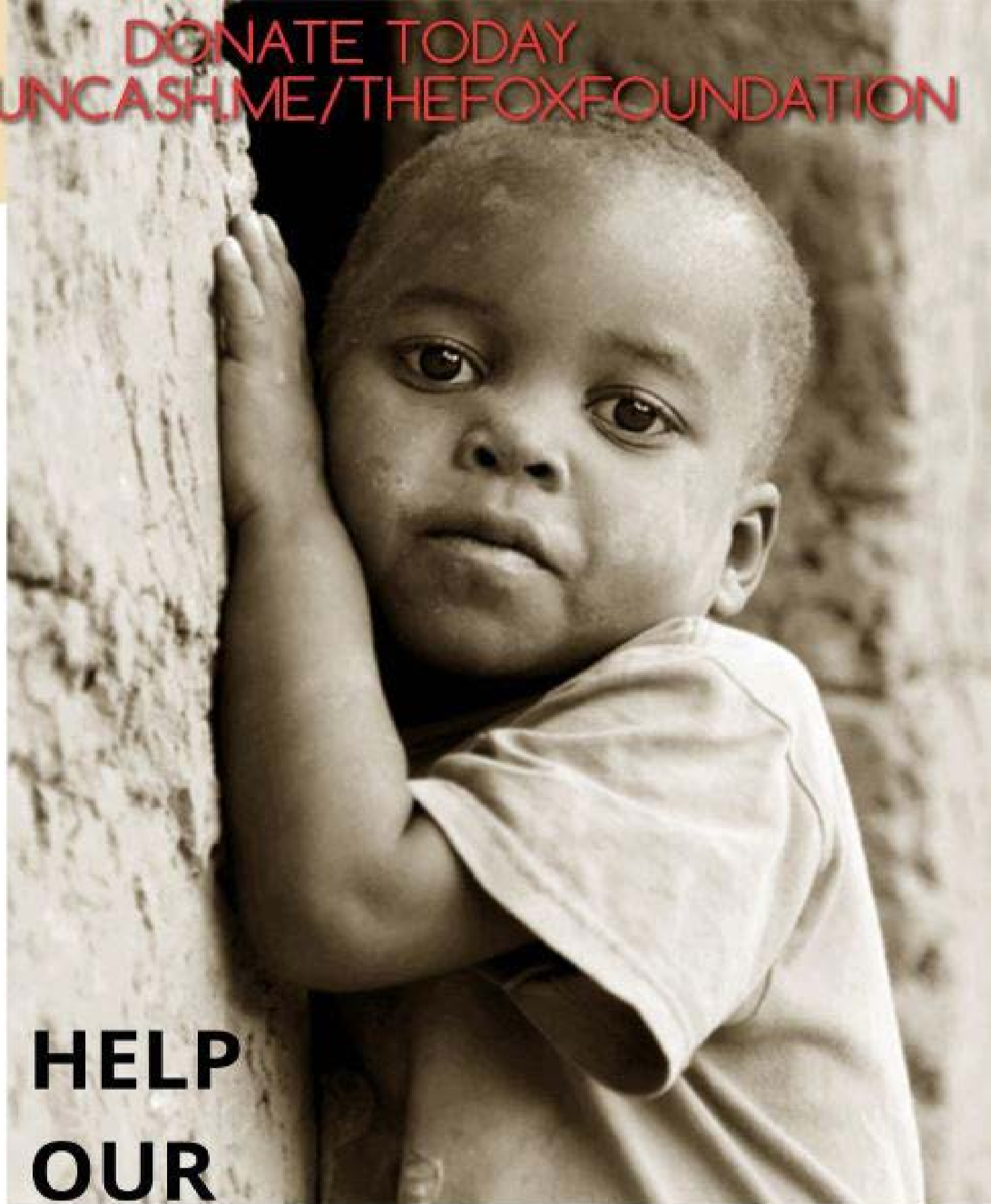
While this looks bad don't get us wrong we still believe in the Police

STEVEN GARDINER BREAKS RECORD AND BRINGS HOME A GOLD MEDAL!

A month after Hurricane Dorian destroyed houses and livelihoods, Steven Gardiner said he was hopeful his world championship victory could bring a little happiness to the Bahamas.

Gardiner's family home on the Abaco islands was one of many damaged in the Sept. 1 hurricane. His win in the 400 meters on Friday prompted a stream of messages from his family and friends still rebuilding their lives there.

"Hurricane Dorian was very devastating for my family and my island. I just wanted to go out

there and do my best," he said.

"My friends and my family, I got messages from all over. They just want me to go out there and perform but I wanted to do a little bit more. I had to fight and I was able to bring home a medal for my country."

It looked as if the Bahamas' chance for gold had gone when favorite Shaunae Miller-Uibo, who said she's donated \$25,000 to hurricane-hit churches, was beaten into silver Thursday in the women's 400 despite setting a North American record.

Gardiner missed Miller-Uibo's race by falling asleep early Thursday,

but watched it on replay at 5 a.m. Both he and Miller-Uibo live in the United States, so they missed the hurricane, but family members were devastated.

Gardiner stepped up to bring the Bahamas gold, smashing his personal best to win in 43.48 seconds, more than half a second clear of Colombian Anthony Zambrano. After taking the win, he took off his shoes, wrapped himself in the Bahamian flag and lay down for a moment of contemplation amid the mayhem.

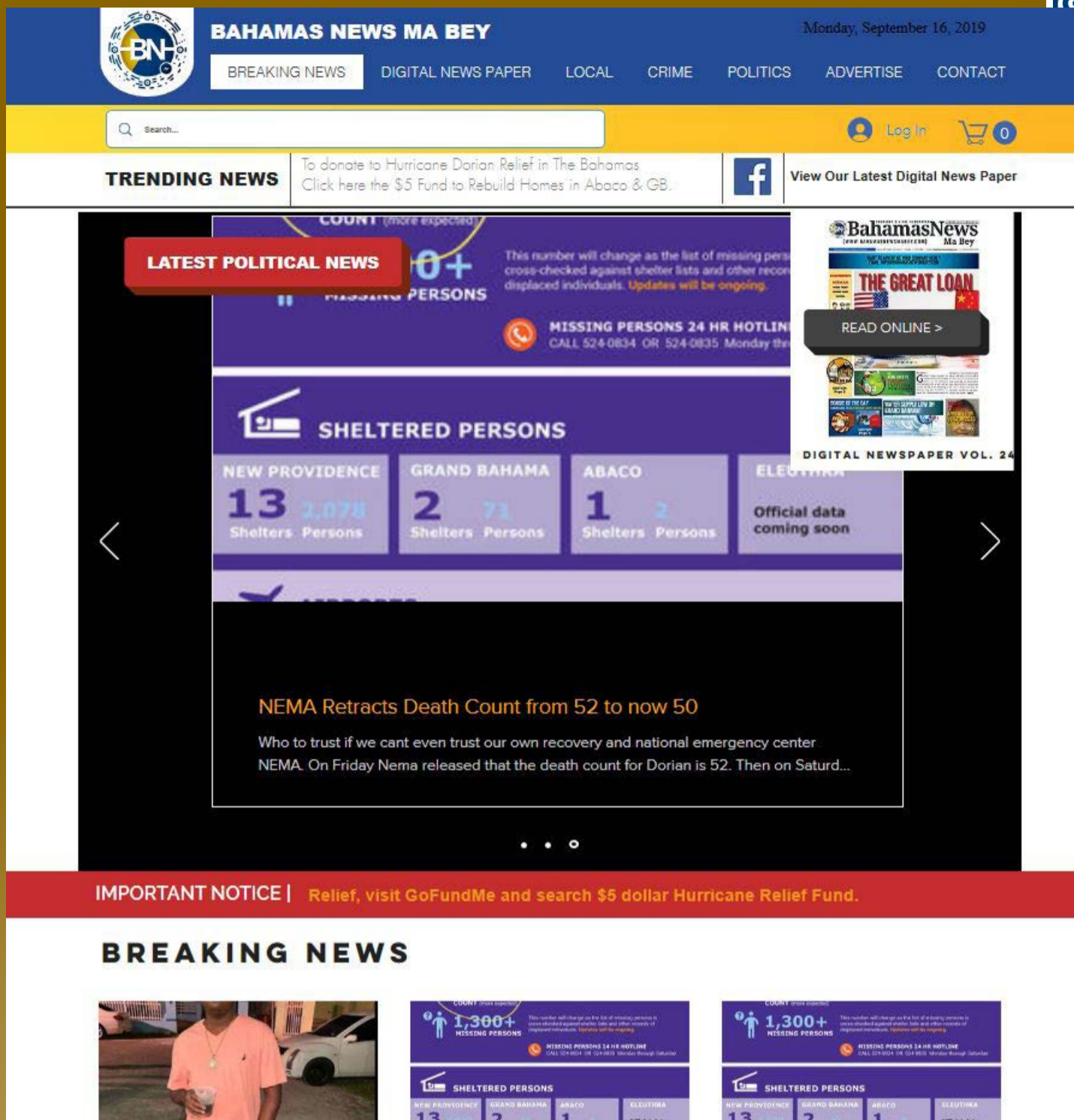
